

AMENDMENT TO ORDINANCE 2020-03
SEPTEMBER 10, 2025

Resolution electing to add to the current No Parking Zones:

ORDINANCE CREATING NO PARKING ZONES ON ELM STREET, BLESSING STREET, MAPLE STREET, AND LARINER DRIVE, SNOW EMERGENCY, TOWN PARKS, AND PARKING ON ALL DESIGNATED TOWN STREETS.

AMENDMENT: WHEREAS, the Town Council desires to promote beautification, traffic safety, and the orderly flow of traffic along all streets in the Town of Millersburg;

NOW, THEREFORE, BE IT ORDERED, ESTABLISHED AND ORDAINED by the Town Council of the Town of Millersburg, Indiana as follows:

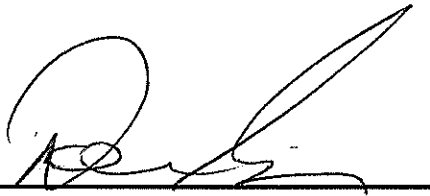
1. Parking is prohibited on the south side of Elm Street and fifteen (15) feet south of the south edge of the Elm Street pavement from the intersection of Jefferson and Elm Streets for a distance of one thousand (1000) feet east along Elm Street.
 - a. Parking is prohibited on both sides of East Washington Street for a distance of eighty (80) feet west of State Road 13. There will be marked designated street parking spaces on both sides of East Washington Street beyond the restricted eighty feet to the North/South alley intersection.
2. Parking is prohibited on the south side of Maple Street and fifteen (15) feet south of the south edge of the Maple Street Pavement.
3. Parking facing traffic is prohibited on all Town designated streets.
4. Parking is prohibited on all posted designated Emergency Snow Routes when snow fall exceeds 2 inches or more until the designated street has been cleared.
 - a. Street parking is prohibited within a cul-de-sac when snow fall exceeds 2 inches or more until the designated area has been cleared.
 - b. Cul-de-sac streeting parking is prohibited from 8:00am-5:00pm Monday through Friday. (Holidays are exempt)
5. Parking is prohibited on both sides of the street of Blessing Street.
6. Angle parking will be changed to parallel parking in the 100 block of East Main Street west of Sherman Street to Jefferson Street.
7. Parking is prohibited at Eagle Park except for the designated parking area along Depot Street which shall be limited to park patrons only.
8. Parking is prohibited on any street, as to create a traffic hazard, in the town limits of Millersburg, Indiana that is a north/south, east/west, two-way, also to include streets

that are angled southeast/northwest, between Clinton Street and Benton Street as long as no driveways, alleys, or fire hydrants are blocked.

9. Parking on Washington Street is allowed, except on special occasions such as on the Farmers Day Parade, or emergency snow route.
10. A fifty-dollar (\$50.00) fine shall be imposed for violations of this Ordinance. In addition to vehicles parked on designated Emergency Snow Routes may be towed at the vehicle owner's expense when the parked vehicle becomes a traffic hazard.
11. Revenues generated from such fines for violations of this Ordinance shall be deposited in the General Fund.
12. This Ordinance shall be effective from and after its passage by the Town Council and publication according to law.

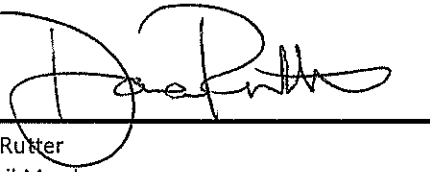

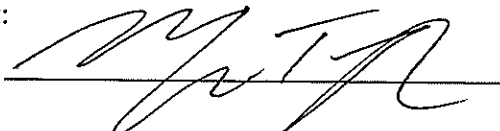
